14th RUFORUM Principals and Deans BUSINESS Meeting

Concept Note

Background

Every year, the Regional Universities Forum for Capacity Building in Agriculture (RUFORUM), a network of 66 universities in 26 African countries, holds its annual general meeting preceded by a number of meetings of its governance organs. These are the Board of Directors, Technical Committee, International Advisory Panel, and Deans and Principals committee. The latter gathers Principals and Deans for Faculties and Colleges Agriculture and related sciences in RUFORUM member universities to discuss issues related to a better and relevant Higher Agriculture Education and Science and Technology in the continent. Because Deans and Principals are the primary custodians of quality Education in universities, the RUFORUM Deans and Principals Committee meetings usually comprises two parts: 1) The open-door sessions where Deans and Principals discuss with other stakeholders various matters geared towards improving Higher education in general and (Higher Agricultural Education and S&T in particular; and 2) The business meeting which is attended solely by Deans and Principals to discuss operations of RUFORUM at University and country level. Such meetings usually issue communiques addressed to the Board of Directors for consideration.

Purpose of the Side Event

The 14th Principals and Deans Business meeting will discuss matters requiring attention for furtherance of the RUFORUM mission in their respective universities and countries, and the network as a whole.
