Thank you Dr. Hlami Ngwenya, University of Free State, South Africa the Moderator for this 9th RUFORUM Webinar on the topic *Delivering Agricultural Advisory Services in the COVID-19 era*.

How do we turn around these experiences for the benefit of the African farmer, characterized as a subsistence small holder? How can we improve production and productivity across the value chain? Noting that issues of postharvest loss and access to markets have been key challenges during this period.

As we explore how agricultural advisory services can be delivered, we draw parallels and lessons for research and community engagement for the universities.



We at RUFORUM believe that this is the opportunity for a multisectoral and multi-disciplinary dialogue to explore solutions not only for agricultural advisory services but for other aspects that will enhance agricultural services on the continent.

The panel of experts we have for this 9th Webinar is diverse and draws experience from agricultural practice, the academe and from the development world who will share their thoughts on how agricultural advisory services can be delivered in this new normal.
